Also included in this charge are our overhead expenses relative to our facility, such as insurance, maintenance and utility expenses, secretarial and administrative costs, taxes, licenses, equipment and inventory expenses. This fee for our services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for discount funeral services, cremation and special packages.)
